WHAT IS **TRUST CODE?**

At Microsoft, our Trust Code is not a static document, but a living commitment that evolves with the changing needs and expectations of the company and the communities we serve.

TRUST CODE COURSE

The Trust Code (Standards of Business Conduct) course is an annual, mandatory training course for all global, full-time Microsoft employees. It uses live-action, episodic video to depict potential workplace situations covering all 24 Trust Code standards in a programmatic way. Each year, a list of relevant policies and risks are included in the course, aligning them with the Trust Code standards.

It demonstrates how to approach ethical challenges with integrity, which is essential to achieving the company's mission of empowering every person and organization on the planet to achieve more.

STORYTELLING

One of the powerful aspects of the Trust Code course is that it uses relatable scenarios where employees can see themselves reflected in the characters and the fast and difficult decisions they must make as part of their day-to-day work. To do so, the Trust Code course follows four development principles-simplicity, clarity, relevancy, and engagement.

Employees are encouraged to "Pause, Think, and Ask," and to "Speak Up" as part of Microsoft's culture of trust.

Working with Subject Matter Experts (SMEs)

Each year, SMEs, policy owners, compliance professionals, and investigators from across the company provide input and guidance on the topics selected for the course to make the scenarios relevant and engaging to employees, while covering the major risks that our company and the industry are facing.

COURSE PRODUCTION

Once the script is finalized, the Trust Code course cast is selected, including any Microsoft employees that will participate in it. The course is introduced by Microsoft leaders that speak about the importance of the course learnings, our culture and values, and how Microsoft Runs on Trust.





The recordings are hosted as a course application in Microsoft's learning platform, Viva Learning, where they go through a severe process of testing by subject matter experts and other employees.

Translation and Accessibility

The final version of the course is translated into multiple languages, so it can be taken by global employees. The course offers multiple accessibility features, such as transcriptions, American Sign Language, and noise suppression.

Trust Code Survey

Key course learnings and further resources are made available for download at the end of the course and ongoing reference.

Employees can provide course feedback via a survey, which helps measure course efficacy and experience, and identify opportunities to continue improving Microsoft's culture. The survey also includes questions regarding Microsoft's culture of trust and employees' willingness to speak up when they see something that's not right.
